**COVID-19 Test Results: 47 New Cases, Six Hospitalized;  
Second COVID-19 Booster Doses Available; Food Commodities Distribution Continues**

**COVID-19 Test Results: 47 New Cases Reported**

Today, the Department of Public Health and Social Services (DPHSS) reported 47 new cases of COVID-19 from 318 specimens analyzed on April 25, 2022. 18 of the cases reported today are through the Department of Defense. To date, there have been a total of 48,020 officially reported cases, 354 deaths, 198 cases in active isolation, and 47,468 not in active isolation.

*SPECIAL NOTE: Based on today's data, if we were to compare two (2) hypothetical populations of 100,000 people each, vaccinated versus unvaccinated, there would be 4 vaccinated people hospitalized for COVID-19 compared to 0 unvaccinated people hospitalized for COVID-19. \*Estimated population is based on DPHSS Immunization Program analysis of 2020 Census data. Updates are expected pending further Census 2020 data breakdown.*

**Second COVID-19 Booster Doses Available**

Second doses of the COVID-19 booster are available to individuals ages 12 years and older who are moderately or severely immunocompromised. Eligible individuals may choose to receive a second booster dose using an mRNA (Pfizer-BioNTech or Moderna) COVID-19 vaccine at least 4 months after the first booster dose.

Additionally, adults between the ages of 18 and 49 who are not moderately or severely immunocompromised and who received Janssen COVID-19 Vaccine as both their primary series dose and booster dose may receive a second booster dose using an mRNA COVID-19 vaccine at least 4 months after the Janssen booster dose.

Adults ages 50 years and older could benefit from a second mRNA booster dose as they are at increased risk for severe COVID-19. Adults 50 years and older may choose to receive a second booster dose, if it has been at least 4 months after the first booster dose.

### Guam COVID-19 Vaccination Update

As of April 25, 2022, a total of **136,324** of Guam’s eligible population (residents 5 years and older) is fully vaccinated. This total includes **13,890** residents 12 – 17 years old. **7,914** residents 5 – 11 years old received their first dose of the Pfizer-BioNTech two dose series. **6,294** residents 5 – 11 years old have completed their two-dose series. A total of **58,179** eligible residents have received their first booster shots. A total of **2,429** eligible residents have received their second booster shots.
