**COVID-19 Test Results: 148 New Cases, Eleven Hospitalized;
 Additional COVID-19 Updates**

COVID-19 Test Results: 148 New Cases Reported

Today, the Department of Public Health and Social Services (DPHSS) reported **148** new cases of COVID-19 from **1,324** specimens collected July 11, 2022. **Thirty-one (31)** of the cases reported today are through the Department of Defense. To date, there have been a total of **53,214** officially reported cases, **373** deaths, **1,023** cases in active isolation, and **51,818** not in active isolation.

*SPECIAL NOTE: Based on today's data, if we were to compare two (2) hypothetical populations of 100,000 people each, vaccinated versus unvaccinated, there would be 5 vaccinated people hospitalized for COVID-19 compared to 26 unvaccinated people hospitalized for COVID-19. The risk of being hospitalized for COVID-19 is about 5 times higher for the unvaccinated as compared to the vaccinated. *Estimated population is based on DPHSS Immunization Program analysis of 2020 Census data. Updates are expected pending further Census 2020 data breakdown.*

COVID-19 Vaccines for Children 6 Months and Older Available at DPHSS CHCs

The Moderna and the Pfizer-BioNTech COVID-19 Vaccines authorized for use in children down to six months of age. In most children, the Moderna COVID-19 vaccine for children ages six months through five years will be a two-dose primary series with four to eight weeks between dose one and dose two. In most children, the Pfizer-BioNTech COVID-19 vaccine for children ages six months through four years will be a three-dose primary series three to eight weeks between dose one and dose two, and at least eight weeks between dose two and dose three.

COVID-19 vaccination for individuals ages six months and older are available at the DPHSS Northern Region Community Health Center in Dededo, and the DPHSS Southern Region Community Health Center in *Inalåhan*. Requirements for minors to receive the Moderna or Pfizer-BioNTech COVID-19 Vaccine:

- Parent/legal guardian must provide minor’s birth certificate
- Parent/legal guardian must have a government-issued photo identification
- Minor must be accompanied by a parent or legal guardian
- Guardians must present legal guardianship or power-of-attorney documents

Incentives Offered for COVID-19 Vaccination Series Completion and Boosters

A program administered by the government of Guam is providing incentives to individuals 12 years of age and older who maintain their COVID-19 vaccinations who are:

- Completing their last dose in primary series; OR
- Receiving 1st Booster Dose OR 2nd Booster Dose

Eligible residents may choose between IP&E gift certificates for \$25 gas at Shell Gas Stations OR \$25 at Shell Foody’s Guam stores (alcohol and tobacco items excluded) *while supplies last*. **Gift certificates will only be offered at vaccination clinics at NRCHC, SRCHC, the Agana Shopping Center, and senior citizen outreach clinics, *while supplies last*.**

Guam COVID-19 Vaccination Update

As of July 11, 2022, **137,350** eligible residents (6 months and older) are fully vaccinated. This total includes **14,418** residents 12 – 17 years old. **8,547** residents 5 – 11 years old received their first dose of a two dose series. **7,153** residents 5 – 11 years old have completed their two-dose series. **53** residents 6 months – 4 years old have received their first dose of a two dose series. **66,700** eligible residents have received their first booster shots. **9,704** eligible residents have received their second booster shots.
