**COVID-19 Test Results: 18 New Cases, 12 Hospitalized;
 Updates to COVID-19 Vaccination Clinic Schedule; Additional COVID-19 Updates**

DPHSS Issues Guidance Memo 2021-16 Rev. 4

Today, the Department of Public Health and Social Services (DPHSS) issued DPHSS [Guidance Memo 2021-16 Rev. 4](#), relative to guidance for individuals who are suspected or confirmed for having COVID-19. Guidance Memo 2021-16 Rev. 4 updates the community on actions to take if an individual is identified as being infected with COVID-19, or if an individual becomes exposed to someone confirmed with COVID-19. The guidance is set in accordance with recommendations set forth by the U.S. Centers for Disease Control and Prevention. Guidance Memo 2021-16 Rev. 4 offers guidance on:

- Testing for COVID-19, including the use of over the counter (OTC) COVID-19 test kits
- Identifying who should get tested for COVID-19, including symptomatic individuals or individuals considered as close contacts to confirmed COVID-19 cases
- Steps to take if you test positive for COVID-19
- Duration of isolation if you test positive for COVID-19
- Prior COVID-19 infections
- Being identified as a close contact

COVID-19 Test Results: 18 New Cases Reported

Today, DPHSS reported **18** new cases of COVID-19 from **322** specimens collected September 15, 2022. **Four (4)** of the cases reported today are through the Department of Defense. To date, there have been a total of **58,370** officially reported cases, **394** deaths, **174** cases in active isolation, and **57,802** not in active isolation.

*SPECIAL NOTE: Based on today's data, if we were to compare two (2) hypothetical populations of 100,000 people each, vaccinated versus unvaccinated, there would be 7 vaccinated people hospitalized for COVID-19 compared to 16 unvaccinated people hospitalized for COVID-19. The risk of being hospitalized for COVID-19 is about 2 times higher for the unvaccinated as compared to the vaccinated. *Estimated population is based on DPHSS Immunization Program analysis of 2020 Census data. Updates are expected pending further Census 2020 data breakdown.*

COVID-19 Vaccination at DPHSS NRCHC Moves to Appointment Basis

Free COVID-19 vaccination services offered at the DPHSS Northern Region Community Health Center (NRCHC) will be performed on an appointment basis Monday through Thursday. COVID-19 vaccination operations held on Saturdays at NRCHC will remain unchanged unless an outreach clinic is scheduled. To schedule an appointment for COVID-19 vaccination at NRCHC, residents must call 671-635-7400 or 671-635-4410 to make appointments.

UPDATE: DPHSS Outreach Clinic Scheduled for Saturday, Sept. 17 Moves to NRCHC

In anticipation of inclement weather this weekend, the DPHSS CHC outreach clinic originally scheduled for Saturday, September 17 at Ypao Beach Park will now operate at the DPHSS Northern Region Community Health Center in Dededo.

Bivalent Boosters Available at DPHSS Vaccination Clinics

On September 2, 2022, the U.S. Centers for Disease Control and Prevention's Advisory Committee on Immunization Practices (ACIP) recommended the use of new bivalent formulations of Pfizer-BioNTech and Moderna mRNA COVID-19 vaccines as a booster dose.

A single booster dose of bivalent Pfizer-BioNTech COVID-19 Vaccine (for individuals age 12 years and older) or bivalent Moderna COVID-19 Vaccine (for individuals age 18 years and older) may be given at least 2 months after completion of a monovalent primary series or any prior monovalent booster dose of COVID-19 vaccine. This new booster recommendation replaces all prior booster recommendations only for people 12 years and older. At this time, there is no change to the monovalent vaccine schedules for children age 6 months through 11 years. Children age 5 through 11 years who have received a Pfizer-BioNTech primary series should continue to receive one monovalent booster dose.

- People must first complete at least a primary series with the original monovalent vaccine before receiving a single bivalent booster at least 2 months later.
- People may receive either brand of bivalent vaccine that is age-appropriate; there is no preference and no need to match the brand of the primary series.
- This recommendation is for a one-time booster. ACIP does not anticipate recommendations for frequent (e.g., every few months) booster doses of bivalent vaccine.
- COVID-19 vaccines may be co-administered with all other routinely recommended vaccines, including influenza vaccine.

The updated boosters are available at the DPHSS vaccination clinics at NRCHC, SRCHC, Agana Shopping Center, and our extended outreach vaccination events.

Novavax COVID-19 Vaccine Available at Northern Region Community Health Center

On August 9, DPHSS received 100 doses of the Novavax COVID-19 vaccine. The U.S. Food and Drug Administration (FDA) issued an Emergency Use Authorization for the Novavax vaccine on July 13. According to the CDC, the Novavax vaccine is a two-dose adjuvanted vaccine that is administered intramuscularly in deltoid muscle in adults 18 years of age or older.

The Novavax vaccine is a two-dose primary series with three to eight weeks between dose one and dose two. Currently, the Novavax vaccine is not authorized for any booster dose. Additionally, individuals who complete their primary series with two doses of Novavax vaccine are not eligible for a booster dose at this time. The Novavax vaccine will be available at the DPHSS Northern Region Community Health Center in Dededo.

DPHSS mAb Treatment Center Open at Paseo Stadium

Bebtelovimab, a monoclonal antibody (mAb) for the treatment of mild-to-moderate COVID-19 in adults and pediatric patients (12 years of age and older weighing at least 40 kilograms) is available at the DPHSS mAb treatment center at the Paseo Stadium in Hagåtña from 9 a.m. to 4 p.m., and closes for lunch from 12 p.m. to 1 p.m., Monday through Saturday.

To schedule treatment at the DPHSS mAb treatment center, patients must call 671-998-4527 or 671-998-4547, have a current, laboratory confirmed COVID-19 infection and a referral from a prescribing physician. COVID-19 Vaccines for Children 6 Months and Older Available at DPHSS CHCs

The Moderna and the Pfizer-BioNTech COVID-19 Vaccines are authorized for use in children from six months of age and older. In most children, the Moderna COVID-19 vaccine for children ages six months through five years will be a two-dose primary series with four to eight weeks between dose one and dose two. In most children, the Pfizer-BioNTech COVID-19 vaccine for children ages six months through four years will be a three-dose primary series three to eight weeks between dose one and dose two, and at least eight weeks between dose two and dose three.

Requirements for minors to receive the Moderna or Pfizer-BioNTech COVID-19 Vaccine at DPHSS vaccination clinics and outreach events:

- Parent/legal guardian must provide minor’s birth certificate
- Parent/legal guardian must have a government-issued photo identification
- Minor must be accompanied by a parent or legal guardian
- Guardians must present legal guardianship or power-of-attorney documents

Incentives Offered for COVID-19 Vaccination Series Completion and Boosters

A program administered by the government of Guam is providing incentives to individuals 12 years of age and older who maintain their COVID-19 vaccinations who are completing their last dose in primary series; OR receiving Monovalent Booster OR Bivalent Booster. Eligible residents will be offered an incentive (alcohol and tobacco items excluded) *while supplies last*.

Gift certificates will only be offered at vaccination clinics at NRCHC, SRCHC, the Agaña Shopping Center, and senior citizen outreach clinics, *while supplies last*.

Guam COVID-19 Vaccination Update

As of September 15, 2022, **140,064** eligible residents (6 months and older) are fully vaccinated. This total includes **14,054** residents 12 – 17 years old. **9,074** residents 5 – 11 years old received their first dose of a two dose series. **7,441** residents 5 – 11 years old have completed their two-dose series. **233** residents 6 months – 4 years old have received their first dose of a two dose series. **70,497** eligible residents have received their first booster shots. **12,518** eligible residents have received their second booster shots.
