End of Day Results: Five Test Positive for COVID-19 by DPHSS, One Confirmed Case from DLS

COVID-19 test results are reported from multiple labs at varying times of the day. The cumulative total from all labs will be reported on a nightly basis, unless unavailable. The following breakdown provides cumulative COVID-19 test results for **Wednesday**, **June 24**, **2020**:

The Department of Public Health and Social Services (DPHSS) tested 319 individuals for COVID-19 on Wednesday, June 24, 2020 with conclusive results. Five tested positive through DPHSS and 314 tested negative for SARS-CoV-2. Results include 174 samples from COVID-19 drive-through testing held at the Barrigada public square next to the old GPD Koban building on Tuesday and 126 samples from COVID-19 drive-through testing held at the Agana Heights Mayor's Office and gymnasium today.

One case tested positive for COVID-19 through Diagnostic Laboratory Services (DLS) and was reported earlier today.

To date, there have been a total of 231 confirmed cases of COVID-19 with 5 deaths, 174 released from isolation, and 52 active cases. Of those cases, 189 are classified as civilians, and 42 are military service members.

Criteria for release of cases from isolation was implemented on May 22. For persons *having symptoms*, at least 10 days have passed since recovery defined as resolution of fever without the use of fever-reducing medications and improvement in respiratory symptoms (e.g., cough, shortness of breath) and any other symptoms attributed to COVID-19 infection AND at least 10 days have passed since symptoms first appeared—or, with recurrent symptoms, at least 10 days have passed since recurrent symptoms appeared—AND at least 14 days have passed since the date of their first (or most recent) positive COVID-19 diagnostic test. For persons *without symptoms*, at least 14 days have passed since the date of their first (or most recent) positive COVID-19 diagnostic test assuming they have not subsequently developed symptoms since their positive test.
