Results: 15 of 1,022 Test Positive for COVID-19; COVID-19 Vaccination Schedule for February 9-13 at UOG Fieldhouse; COVID-19 Homebound Vaccinations Continue

Results: 15 New Cases of COVID-19

Fifteen (15) new cases of COVID-19 were identified out of **1,022** tests performed by the DPHSS on Sunday, February 7, and tests from additional labs from Friday, February 5 to Sunday, February 7. **Eight (8)** cases reported recent travel history and were identified in quarantine. **Eight (8)** cases were identified through contact tracing. *Note: This breakdown includes the 13 cases previously reported by the Joint Information Center since Friday, February 5, 2021.

To date, there have been a total of **7,664** officially reported cases of COVID-19 with **130** deaths, **103** cases in active isolation, and **7,431** not in active isolation.

¹The COVID Area Risk (CAR) Score accounts for the incidence of new cases, how well current testing identifies these cases, and the rate of spread. The ideal long-term goal is to sustain a CAR Score of 2.5 or less, which has been shown to correlate with very low to zero COVID-related hospitalizations and deaths.

COVID-19 Vaccination Schedule for February 9-13 at UOG Fieldhouse

COVID-19 vaccination clinics continue Tuesday, February 9 through Saturday, February 13 at the UOG Fieldhouse from 1 p.m. to 7 p.m. These clinics will prioritize those due for their second dose of the Pfizer-BioNTech or Moderna vaccine. Pfizer-BioNTech first doses will be limited to 50 per hour for eligible individuals. No first doses of the Moderna vaccine will be administered. Residents are advised to schedule an appointment online via Eventbrite. Click here to schedule and to learn more about eligibility requirements.

Due to a higher demand for second dose vaccines on Wednesday, February 10, there is a separate Eventbrite link to schedule appointments. This clinic will prioritize those due for their second dose of the Pfizer-BioNTech or Moderna vaccine. Pfizer-BioNTech first doses will be limited to 50 per hour for eligible individuals. No first doses of the Moderna vaccine will be administered. Click here to schedule and to learn more about eligibility requirements.

Upon arrival, individuals 70 years and older will be sent to the front of the line. Please bring a digital or hard copy appointment confirmation and a photo ID. Those due for their second dose are reminded to bring their COVID-19 immunization card. This ensures quicker processing and proper documentation.

COVID-19 Homebound Vaccinations Continue February 9 – 12

DPHSS, in partnership with the MCOG, and GDOE, continues homebound vaccinations for those who pre-registered with their respective village mayors and met the eligibility criteria. The homebound vaccinations schedule for this week is as follows:

Pre-screening Eligibility for COVID-19 Vaccinations

To take the COVID-19 vaccine, you must meet the following pre-screening eligibility criteria*:

- Must not be currently infected with COVID-19 or previously exposed within the last 14 days
- Must not have received any other vaccine, such as the flu shot, in the last 14 days

V-Safe Vaccine Symptom Monitoring

^{*}Please note: If this is your first time receiving the COVID-19 vaccine, please make sure you have never taken other COVID-19 vaccine products. Please visit dphss.guam.gov to view the pre-screening eligibility.

After receiving the COVID-19 vaccine, register for v-safe, offered by the U.S. Centers for Disease Control and Prevention (CDC). V-safe is a smartphone-based tool that uses text messaging and web surveys to provide personalized health check-ins. You can quickly report side effects and depending on your answers, you may receive a call from CDC. V-safe will remind you to get your second dose of the COVID-19 vaccine. Sign up at vsafe.cdc.gov.

Do Not Share Images of Your Vaccination Card on Social Media

Refrain from sharing images of your COVID-19 vaccination card on social media. Vaccination cards contain sensitive information (full name, birth date, and location), making you susceptible to identity theft. Keep your vaccination card safe at all times.
