**Two of 494 Test Positive for COVID-19; COVID-19 Community Testing Schedule;
COVID-19 Vaccination Schedule; Food Commodities Distribution Schedule**

Results: Two New Cases of COVID-19

Two (2) new cases of COVID-19 were identified out of **494** tests performed Monday, April 5.

Two (2) cases reported recent travel history and were identified in quarantine. To date, there have been a total of **7,825** officially reported cases of COVID-19 with **136** deaths, **28** cases in active isolation, and **7,661** not in active isolation. **The CAR Score is 0.2.**

Additionally, the [U.S. Food and Drug Administration's February 25, 2021 revision](#) of their Fact Sheet relative to the Pfizer-BioNTech Emergency Use Authorization now states, "After dilution, one vial contains six doses of 0.3 mL. Vial labels and cartons may state that after dilution, a vial contains five doses of 0.3 mL. The information in this [Fact Sheet](#) regarding the number of doses per vial after dilution supersedes the number of doses stated on vial labels and cartons." | ^{^^}Reflects the previous allocation total of 86,560 and last received an allocation of 1,300 Johnson & Johnson Janssen vaccines on April 3, 2021, 25,740 Pfizer-BioNTech vaccines and 15,000 Moderna vaccines on April 4, 2021.

COVID-19 Community Testing Schedule

COVID-19 community testing will be held at the locations and times below. No symptoms are needed to qualify for testing. Bring a photo ID. For the safety of the community and nurses, only four (4) people per vehicle are allowed to be tested. **Testing for travel purposes will not be conducted at these community testing sites. Individuals seeking COVID-19 testing to travel off-island may contact the DPHSS Northern Region Community Health Center at 635-7525/6 to schedule an appointment.**

Minors must be accompanied by a parent or legal guardian and provide government-issued identification to validate age. The parent or legal guardian will also be required to sign a consent form on behalf of the minor to be tested for COVID-19.		

COVID-19 Vaccination Schedule

Village-based COVID-19 vaccination clinics continue at the locations and times below. Bring a photo ID. Although walk-ins are accepted, residents are encouraged to register with their respective mayor's office. Those due for their second dose are reminded to bring their COVID-19 immunization card.
